



The part of the lecture mentioned above relates to the physical building, of course. But it is also a metaphor for the esoteric building which makes up the lodge defined as a group of men coming together and learning life lessons. This also is a building process. There is a plan of what is the right thing to do and there are the workers who put in their own person as asset to the whole. It is essential that the lodge works together as a team as described in the temple building example.

Only that way the goal of a perfect building will be achieved. Everyone puts in the part they are good at and with



THE DUTIES OF A LODGE INVESTIGATOR

(Part II of III) Submitted by Gene Wickey

Part I of this article dealt primarily with a Lodge member being appointed to serve as an investigator to gather information on a Petitioner and, at the conclusion, file a Report with the Master of the Lodge. The importance of this appointment cannot be over emphasized. It goes without saying that one of the more important duties of the Master is the appointment of members of the Lodge to an investigating Committee. The appointment should be considered an honor since the Master has placed his trust and confidence in the member's ability to conduct a complete, proper, and thorough investigation. If the assignment, and the duties related thereto, are not carried out properly, the member has not only let the Master down, but all of the members of the Lodge. You may ask, why is that the case? It's because the members, who must cast a ballot, are entitled to rely on the Report submitted as I stated in Part I. It's so important that it's worth repeat-

Part I touched upon how the investigator should conduct the investigation. At the outset I should mention that there are wrong ways; right ways; and different ways. The last two are okay since each investigator probably has a different modus operandi (Latin for "manner or method of operation or procedure").

As you know, the members of the investigation Committee are the first (or second) line of defense against one who is deemed to be unworthy of admission to the fraternity. No phase of Masonic work is more important than the thorough, impartial, and unbiased investigation of those who seek admission into our ranks.

I mentioned "first or second line of defense". Let me explain. In my opinion, the first line of defense is with the Brothers who sign the Petitioner's Petition and therefore vouch for his reputation, character, integrity, honesty, and all of the other attributes we are looking for. On many occasions, the signers have not known the Petitioner very long and may not have conducted any investigation at all. Some may feel it's not really required as a signer, and I'm guessing that there may be several schools of thought on this. I think it's fair to say that the signers have an obligation to make sure they feel the Petitioner is suitable and worthy to join the fraternity. In some cases, where the signers know very little about the Petitioner, it makes the duties of the investigators even more important! (I'm referring generally to those situations where the signers have only known the Petitioner for a very short period of time and know very little about the Petitioner).

From The Secretary



At the annual communication an increase of four dollars (\$4) in the annual per-capita was approved. Our lodge By-Laws (Article IX, Section 1) spells this out by saying "In addition to Grand Lodge percapita and any special assessments, the dues of each member of this Lodge shall be eighty-four dollars (\$84.00) per year. The sum of Grand Lodge per-capita, special assessments, and Lodge dues are payable in advance." For 2020 this means our dues will be \$122 (\$126 if paying by PayPal). This equates to \$84 (dues) + \$38 (per-capita) for a total of \$122. The extra \$4 for PayPal is to cover their transaction fees.


